

Supplier Code of Conduct

Introduction

NIU Technologies (together with its subsidiaries and consolidated affiliated entities, "NIU", "We" or the "Company") is committed to maintaining the highest standards of corporate governance, ethical conduct, and social responsibility. This Supplier Code of Conduct ("Code") outlines the expectations and requirements for our suppliers to ensure alignment with our values and responsibilities. NIU requires suppliers to operate in accordance with the Code.

Legal and Ethical Compliance

- **Legal Compliance:** Suppliers must fully comply with all applicable laws and regulations within their respective countries or regions of operation. This includes but is not limited to labor laws, environmental regulations, and anti-corruption statutes. By adhering to these legal requirements, suppliers demonstrate their commitment to conducting business ethically and responsibly.
- **Ethical Standards:** Suppliers are expected to uphold the highest ethical business practices and demonstrate integrity in all interactions with NIU Technologies and its affiliates. This includes transparency in business dealings, honest communication, and maintaining the highest standards of professionalism.

Environmental Responsibility

Labor Standards

- **Fair Labor Practices:** Suppliers must adhere to fair labor practices, ensuring there is no child labor, forced labor, or discrimination of any kind. This includes

respecting workers' rights to freedom of association and collective bargaining, and providing equal opportunities for employment and advancement.

- **Wages and Conditions:** Suppliers shall provide fair wages and safe working conditions that meet or exceed local legal standards. Workers must be compensated fairly for their labor, and their physical and mental well-being must be protected through safe and healthy working environments.
- **Health and Safety:** Suppliers are required to maintain a safe and healthy work environment, comply with occupational health and safety laws, and actively prevent work-related accidents and injuries. This includes regular training for employees on safety procedures and providing appropriate personal protective equipment.

Quality and Continuous Improvement

- **High-Quality Standards:** Suppliers are expected to deliver high-quality products and services, demonstrating a commitment to continuous improvement and innovation. This commitment ensures that the products and services meet or exceed customer expectations and industry standards.
- **Quality Management Systems:** Suppliers must implement robust quality management systems to ensure consistent product and service excellence. These systems should include rigorous testing protocols, quality assurance measures, and ongoing training for employees to maintain the highest levels of quality.

Intellectual Property and Confidentiality

- **Intellectual Property Rights:** Suppliers must respect and protect the intellectual property rights of NIU Technologies and all other parties. This includes patents, trademarks, copyrights, and trade secrets. Suppliers are expected to use such intellectual property only as authorized and to take appropriate measures to prevent infringement.
- **Confidential Information Protection:** Confidential information received from NIU Technologies must be safeguarded and not disclosed to unauthorized third parties under any circumstances. This includes implementing strict data protection policies and procedures to ensure the confidentiality of sensitive information.

Anti-Corruption and Fair Competition

- **Zero Tolerance for Corruption:** Suppliers must avoid any form of bribery, corruption, or unfair competition practices. This includes refraining from offering, promising, giving, or accepting bribes or kickbacks in any form.
- **Transparency and Fairness:** Fair and transparent business dealings are essential in all transactions and relationships with NIU Technologies. This includes being honest about capabilities, performance, and pricing, and engaging in open and respectful communication.

- **Prohibition of Bribery.** Suppliers are strictly prohibited from offering, promising, authorizing or giving money or anything of value to any government official or entity with the objective of influencing official acts or decisions of that person or entity, securing any kind of improper advantage, or obtaining or retaining business.
- **Solicitation of Bribery.** Suppliers are strictly prohibited from soliciting or accepting anything of value in order to secure to a third party any kind of improper advantage relating to a business relationship with the Company.

Additional Considerations

- **Supplier Diversity:** We are committed to developing a diverse supplier base with fair and equitable business practices regardless of organization size or business form.
- **Human Rights:** Suppliers are expected to respect human rights and ensure that their operations do not contribute to human rights abuses. This includes promoting the well-being of workers and respecting the rights of individuals in the communities where they operate.
- **Community Engagement:** Suppliers should engage positively with the communities in which they operate, supporting local development and initiatives where possible. This includes being good corporate citizens by contributing to community welfare and participating in social responsibility programs.

Communication

- **Reporting Mechanisms:** Suppliers must establish and maintain effective mechanisms for reporting non-compliance and grievances. This includes setting up anonymous reporting channels and ensuring that all reports are handled promptly and confidentially.
